- All members must conduct club activities with consideration and respect for other members.
- Members must not dive beyond their qualifications and depth limits set out by their training agency.
- All members must adhere to their training agency's Standard Safe Diving Practices.
- Payments received for boat bookings are passed directly on to the boat operators and are not refundable except in circumstances of adverse weather forcing cancellation.
- Boat places booked with credit cards will be liable to a 2% surcharge.
- For safety reasons each diver must carry a delayed SMB and reel when conducting coastal dives.
- A 3 minute safety stop should be completed on all club dives.
- All members are responsible for their own assessment of their physical ability and level of health, relating to the dives being carried out.
- All members must submit a signed 3D Diving Scuba Diving Certificate of Understanding and Assumption of Risk form.

## Scuba Diving Certificate Of Understanding And Assumption Of Risk

Please read carefully and fill in all blanks before signing.

I \_\_\_\_\_ hereby affirm that I have been advised and thoroughly informed of the inherent hazards of skin diving and scuba diving.

I understand this Certificate of Understanding and Assumption of Risk Certificate hereby encompasses and applies to all diving activities in which I choose to participate as part of the 3D Diving Club. These specialised activities may include but are not limited to, navigation, night, deep, altitude, boat, drift, dry suit, wreck, multilevel, search and recovery, underwater naturalist, underwater photography, Enriched Air Nitrox, Trimix and decompression dives.

I understand this Certificate encompasses and applies to select 3D Diving Club speciality workshops in which I choose to participate.

I understand and agree that this certificate applies to all members of 3D Diving, agents and assigns of 3D Diving through which such activities, as identified above are conducted.

I understand that scuba diving involves certain risks including decompression sickness, embolism or other hyperbaric injuries that require treatment in a recompression chamber. I further understand that the diving trips may be conducted at sites that are remote in time, distance, or both, from such a recompression chamber. Despite the possible lack of a recompression chamber near the dive site, I still choose to participate with diving activities.

I understand that neither my buddy(ies), other club members, boat skippers, nor any of their respective employees, officers, agents or assigns of the facility 3D Diving (hereinafter referred to as "Released Parties") may be held liable or responsible in any way for any injury, death or other damages to me or my family, heirs or assigns that may occur as a result of my participation in these diving activities or as a result of any matter under my control.

As a condition of being allowed to enroll with 3D Diving, I hereby personally assume all risks in connection with said activities, for any harm, injury or damage that may befall me while I am enrolled as a member of 3D Diving with said activities, including all risks connected therewith, whether foreseen or unforeseen and I further understand that obtaining an insurance policy is in my best interest.

I also understand that skin diving and scuba diving cause physical strain or exertion not necessarily experienced in non-diving situations, and that I assume all risk for, and will not hold the released parties responsible for, any injuries due to heart attack, panic, hyperventilation or other injuries caused by physical strain and exertion.

I further state that I am of lawful age and legally competent to sign this Certificate, or that I have acquired the written consent of my parent or guardian.

I hereby state and agree that this Certificate will be effective and valid for all diving activities as defined above for a period of one year from the initial date on which I execute this Certificate.

I understand that the terms herein are contractual and not a mere recital, and that I have signed this document of my own free act.

IT IS THE INTENTION OF \_\_\_\_\_ (members name) BY THIS DOCUMENT TO EXEMPT AND RELEASE MY BUDDY(IES), 3D DIVING MEMBERS AND THE FACILITY THROUGH WHICH I RECEIVE CLUB MEMBERSHIP AND ALL RELATED ENTITIES AS DEFINED ABOVE, FROM ALL LIABILITY OR RESPONSIBILITY WHATSOEVER FOR ALL PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH, WHICH RESULTS FROM MY OWN CONDUCT OR ANY MATTER OR CONDITION UNDER MY CONTROL.

I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS CERTIFICATE OF UNDERSTANDING AND ASSUMPTION OF RISK BY READING IT BEFORE I SIGNED IT ON BEHALF OF MYSELF AND MY HEIRS. I FURTHER UNDERSTAND AND AGREE THAT THIS CERTIFICATE IS EFFECTIVE AND VALID FOR A PERIOD OF ONE YEAR FROM THE DATE ON WHICH I EXECUTE THIS CERTIFICATE.
